##### **1. Adoption of Remuneration Report**

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

*"That, for the purposes of section 250R(2) of the Corporations Act 2001 (Cth) and for all other purposes, the Remuneration Report for the Company and its controlled entities for the period ended 30 June 2010 be adopted."*

The vote on this Resolution is advisory only and does not bind the Directors or the Company.

##### **2. Re-election of Dr Marcello de Angelis as a Director**

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

*"That Dr Marcello de Angelis, who was appointed as a director of the Company to fill a casual vacancy on 19 October 2009, retires in accordance with the Company's constitution and being eligible, offers himself for re-election, be re-elected as a Director."*

##### **3. Re-election of Mr Christopher Reindler as a Director**

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

*"That Mr Christopher Reindler, who retires by rotation in accordance with the Company's constitution and being eligible, offers himself for re-election, be re-elected as a Director."*

#### **4. Appointment of Auditor**

To consider and, if thought fit, to pass, with or without amendment, the following resolution as an **ordinary resolution**:

**EXPLANATORY MEMORANDUM**

This Explanatory Memorandum has been prepared for the information of Shareholders in connection with the business to be considered at the first Annual General Meeting of Shareholders to be held at the Celtic Club, 48 Ord Street, West Perth, Western Australia at 3.30pm (WST) on Wednesday, 24 November 2010.

The Explanatory Memorandum should be read in conjunction with the accompanying Notice of Annual General Meeting. For the assistance of Shareholders, a glossary of defined terms is included at the end of this Explanatory Memorandum.

Full details of the business to be considered at this Annual General Meeting are set out below.

---

**Annual financial statements and reports**

The Corporations Act requires that the Annual Report (which includes the Annual Financial Report, Directors' Report and Auditor's Report) be laid before the Annual General Meeting.

Shareholders will be given an opportunity to ask questions and make comments about the Annual Report or the Company generally but there will be no formal resolution submitted to the Meeting in respect of it.

Mr Wayne Clark, as the auditor responsible for preparing the Auditor's Report for the year ended 30 June 2010 (or his representative) will attend the Meeting. The Chairman will also allow a reasonable opportunity for Shareholders to ask the auditor questions about:

- (a) the conduct of the audit;
- (b) the preparation and content of the Auditor's Report;
- (c) the accounting policies adopted by the Company in relation to the preparation of financial statements; and
- (d) the independence of the auditor in relation to the conduct of the audit.

To assist the Board and the auditor of the Company in responding to questions please submit any questions you may have by mail to the Company's office, **PO Box 1255, West Perth WA 6872**, or by fax to **+61 8 9322 7705** so that it is received by no later than 5.00pm (WST) on Wednesday, 17 November 2010.

As required under section 250PA of the Corporations Act, at the Meeting, the Company will distribute a list setting out the questions directed to the auditor received in writing from members, being questions which the auditor considers relevant to the content of the Auditor's Report or the conduct of the audit of the Annual Financial Report for the year ended 30 June 2010. The Chairman will allow reasonable opportunity to respond to the questions set out on this list.

## **1. Resolution 1 - Adoption of Remuneration Report**

The Remuneration Report of the Company for the financial period ended 30 June 2010 is set out on pages 13 to 17 of the Company's 2010 Annual Report.

Pursuant to section 250R(2) of the Corporations Act, a resolution that the Remuneration Report be adopted must be put to vote at the Company's Annual General Meeting. The vote on this Resolution is advisory only and does not bind the Directors or the Company. However, the Board will take the outcome of the vote into consideration when reviewing the remuneration practices and policies of the Company.

A reasonable opportunity will be provided for discussion of the Remuneration Report at the Meeting.

The Board unanimously recommends that Shareholders vote in favour of adopting the Remuneration Report.

## **2. Resolutions 2 and 3 - Re-election of Directors**

It is a requirement under the Company's constitution that Dr Marcello de Angelis, who was appointed to fill a casual vacancy on 19 October 2009, retires at the Annual General Meeting. Dr de Angelis, being eligible for re-election pursuant to the Company's constitution, offers himself for re-election.

Apart from Dr de Angelis (who abstains from voting given his interest in the Resolution), the remaining Directors recommend to Shareholders that Dr de Angelis be re-elected.

It is a requirement under the Company's constitution that Mr Christopher Reindler retires by rotation at the Annual General Meeting. Mr Reindler, being eligible for re-election pursuant to the Company's constitution, offers himself for re-election.

Apart from Mr Reindler (who abstains from voting given his interest in the Resolution), the remaining Directors recommend to Shareholders that Mr Reindler be re-elected.

## **3. Resolution 4 – Appointment of Auditor**

HLB Mann Judd were appointed as auditor of the Company in accordance with Section 327(1) of the Corporations Act. That appointment will lapse, in accordance with Section 327(2) of the Corporations Act at the first annual general meeting of the Company. Section 327(3) of the Corporations Act requires the appointment of an auditor at a company's first annual general meeting.

HLB Mann Judd has been duly nominated for appointment as the Company's auditor by a member, as required by Section 328 of the Corporations Act. A copy of the nomination letter forms part of this Notice.

The Board unanimously recommends that Shareholders vote in favour of the appointment of HLB Mann Judd as the Company's auditor.

"**Board**" means the Board of Directors of the Company.

"**Company**" means Raisama Limited ABN 79 131 843 868.

"**Constitution**" means the Company's constitution from time to time.

"**Corporations Act**" means the *Corporations Act 2001 (Cth)*.

"**Directors**" means the directors of the Company from time to time.

"**Directors' Report**" means the director's report contained in the Annual Report.

"**Explanatory Memorandum**" means the explanatory memorandum that accompanies and forms part of this Notice.

"**Listing Rule**" means a Listing Rule of ASX Limited.

"**Meeting**" or "**Annual General Meeting**" means the annual general meeting of Shareholders of the Company convened by this Notice.

"**Notice**" or "**Notice of Annual General Meeting**" means the notice of annual general meeting which accompanies this Explanatory Memorandum.

"**Remuneration Report**" means the remuneration report appearing in the Annual Report.

## PROXY AND VOTING ENTITLEMENT INSTRUCTIONS

### PROXY INSTRUCTIONS

Shareholders are entitled to appoint up to two individuals or bodies corporate to act as proxies to attend and vote on their behalf. Where more than one proxy is appointed each proxy may be appointed to represent a specific proportion of the Shareholder's voting rights. If the appointment does not specify the proportion or number of votes each proxy may exercise, each proxy may exercise half of the votes.

The proxy form (and the power of attorney or other authority, if any, under which the proxy form is signed) or a copy or facsimile which appears on its face to be an authentic copy of the proxy form (and the power of attorney or other authority) must be deposited at or sent by facsimile transmission to the Company's office, **PO Box 1255, West Perth WA 6872, +61 8 9322 7705**, not less than 48 hours before the time for holding the Meeting, or adjourned meeting as the case may be, at which the individual or body corporate named in the proxy form proposes to vote.

The proxy form must be signed by the Shareholder or his/her attorney duly authorised in writing or, if the Shareholder is a corporation, in a manner permitted by the Corporations Act.

The proxy may, but need not, be a Shareholder of the Company.

In the case of Shares jointly held by two or more persons, all joint holders must sign the proxy form.

### VOTING ENTITLEMENT

For the purposes of determining voting entitlements at the Meeting, Shares will be taken to be held by the persons who are registered as holding the Shares at 5.00pm (WST) on Monday, 22 November 2010. Accordingly, transactions registered after that time will be disregarded in determining entitlements to attend and vote at the Meeting.

Mr Wayne Clark, as the auditor responsible for preparing the Auditor's Report for the year ended 30 June 2010 (or his representative) will attend the Meeting. The Chairman will also allow a reasonable opportunity for Shareholders to ask the auditor questions about:

- (a) the conduct of the audit;
- (b) the preparation and content of the Auditor's Report;
- (c) the accounting policies adopted by the Company in relation to the preparation of financial statements; and
- (d) the independence of the auditor in relation to the conduct of the audit.
